\*\*In addition to these discretionary funded programs, the President proposes the following new mandatory funded programs:

- \$75 billion over ten years for the Preschool for All program. \$1.3 billion is proposed for ED in FY2014.
- \$5 billion in one-time mandatory funds for the RESPECT Project
- \$12.5 billion in one time funds for an educator jobs fund.
- \$4 billion in mandatory funds, beginning in fiscal year 2015, for a Community College to Career Fund that would support community college-based training programs and other activities that help prepare workers for jobs in high-growth and high-demand sectors.
- \$190 million for the Presidential Teaching Fellows program, which is specifically focused on ensuring that
  recipients enter, remain, and thrive in the field of teaching.

<sup>&</sup>lt;sup>1</sup> The request for State Grants includes \$74.7 million for the English Literacy/Civics Education set-aside to help States and communities provide adults learning English with expanded access to high-quality English literacy programs linked to civics education.

<sup>&</sup>lt;sup>2</sup> The President is requesting \$1 billion for a new Race to the Top–College Affordability and Completion competition that would drive change in State higher education policies and practices in order to improve college access, affordability, completion, and quality. There would be no funds allocated for RTT P-12 competitions in FY 2014, but the President wants to retain the ability to reinstate these competitions in future funding cycles. The Senate Appropriations Committee proposed no funds for the RTT- P-12 competition in FY2014 but did provide \$100 million for the RTT- College Affordability and Completion competition.

The budget request proposes to restructure the Perkins Loan program as a mandatory credit program and to expand institutional participation by up to an additional 2,700 postsecondary education institutions. The Committee bill does not include this proposal and provides no new loans for the program.
