ONE MILLION RALLY FOR AFTERSCHOOL

At more than 7,500 sites across the country and U.S. military bases around the world, a million people came together in October to rally for the afterschool programs that keep kids safe, inspire them to learn, and help working families.

At *Lights On Afterschool* rallies and celebrations, students conducted science experiments, learned about healthy eating, cleaned up neighborhoods, helped senior citizens, and discussed the importance of afterschool programs with lawmakers, business and community leaders, parents, and others.

The Empire State Building in New York City and the Lindbergh Center atop the Los Angeles City Hall were lit up that evening in honor of the event.

"The range of activities taking place for *Lights On Afterschool* were as varied and exciting as the activities that engage children in afterschool programs every day," said Afterschool Alliance Executive Director Jodi Grant. "But the sad truth is that too many children have no access to afterschool programs. Our new household survey, sponsored by the JCPenney Afterschool Fund, found that more than 15 million kids in this country are unsupervised each afternoon after the school day ends. We need to do more to ensure that every child will have a safe place to go, with adult supervision and fun, educational activities, each afternoon."

Policymakers Lend Support

President Barack Obama issued a proclamation for *Lights On Afterschool*. It said, in part: "I am pleased to send greetings

to all those marking the 10th Annual *Lights On Afterschool* celebration. The most important investment we can make for our Nation's long-term prosperity is the education of our future leaders. Their learning should not begin and end with the school bell, and afterschool programs provide continued opportunities for our students to learn and grow."

Forty-nine governors also issued proclamations for *Lights On Afterschool* this year.

By unanimous consent, the United States Senate passed a bipartisan resolution introduced by Senator Christopher Dodd (D-CT) supporting Lights On Afterschool. "As the father of two school-aged children, I know how critical high-quality afterschool programs can be for millions of children and their families," Dodd said. "These programs engage students in their communities and keep our children safe, paving the way for success in their educational endeavors. I am proud to join countless parents, students, teachers and communities in celebrating afterschool programs nationwide." Senator Dodd is co-chair of the Senate Afterschool Caucus, along with Senator John Ensign (R-NV).

Spotlight on Local Events

In every corner of the country, this year's *Lights On Afterschool* events highlighted how afterschool programs benefit communities. They also gave students, parents, elected officials and community leaders a chance to connect – and shone a spotlight on the tremendous unmet need for afterschool programs.

Power a Bright Future

Clorox Clean-Up has announced the "Power a Bright Future" grant program, to sustain programs for children that might otherwise be reduced or eliminated because of the recession. Five programs will be awarded a \$10,000 grant, and will be featured in an advertisement in *People Magazine*. Any non-profit organization or program that helps children is eligible to apply. A panel that includes representatives from the National Education Association Health Information Network, Mom Central Consulting and Extraordinary Mommy.com will choose 50 semi-finalists. The public will vote online for their favorite program, and the five winners will be announced in January. Entries must include a photo and a short essay describing the program. "After-school programs are a cost-effective way to boost student achievement, reduce juvenile crime and help overstressed working parents. Yet a new study finds that the number of after-school slots continues to lag far behind parents' demand. Even in these hard economic times, it should be possible to narrow the gap... During the 2008 campaign, then-Senator Barack Obama promised that he would double the financing for after-school programs under the No Child Left Behind Act. His budget plan unveiled in February called for no increase in the current \$1.1 billion appropriation. The House has approved a spending bill that adds another \$50 million for after-school programs. The Senate should at least agree to that... President Obama, his education secretary, Arne Duncan, and Congress must all acknowledge that a lot more is needed and quickly come up with a plan to increase financing for quality afterschool programs."

IN THE NEWS...

National – A study released by Tufts University and the National 4-H Council finds that students who participate in 4-H outperform their peers in science, technology and engineering, and often go on to pursue careers in those areas. It also finds that the longer children are involved, the more benefit they get from the program, and girls benefit more than boys, the Associated Press reports. "What we're saying is greater doses of 4-H give your kid an advantage," said lead researcher Richard Lerner, director of the Institute for Applied Research in Youth Development at Tufts University. Arizona – The state's Department of Health Services has announced a drastic increase in licensing fees that afterschool leaders say will hinder their ability to provide programs to children and families that need them. The fees, which take effect January 1, will be passed on to the parents of about 260,000 children served by Arizona afterschool programs, the Arizona Republic reports. "[Parents are] already making choices not to enroll their kids based on what else is going on in the economy. This will just make it more difficult," said Vicki Catlett-Newby, child care and community education coordinator for the Paradise Valley Unified School District. The licensing fee will change from a flat rate to a per-child rate, and could increase as much as 8,800 percent for some programs. The change will also affect hospitals, nursing homes and assisted living facilities.

California – Once called the most dangerous town in America, Compton is turning around thanks in part to several gentle giants, *NBC Nightly News* reports. Kids in the Compton Junior Posse stay out of trouble with free

horseback riding lessons, in exchange for good grades and behavior. "This was a way for them to be able to have a support system for them to be able to say no [to gangs]," program director Mayisha Akbar said. "They learn to respect life by dealing with these horses." Students also take care of the animals and the ranch, participate in competitions, and train with experts like Olympic gold medalist Will Simpson. New Jersey – The State Senate passed a law requiring the boards of education in more than 20 low-income communities to develop comprehensive plans for afterschool activities. According to Public Law 80, each plan must include goals and objectives, a description of all activities, qualifications of the employees, a schedule, eligibility requirements and overall cost. "The success of our children greatly depends on their ability to be involved in high-quality afterschool programs that enhance learning and help them grow," State Senator Ronald Rice (D-Essex) said. "Afterschool programs empower children to excel because they help develop students' emotional and academic skills in a safe environment. We can't expect our children to stay no to gangs and drugs if we don't provide them with an alternative to life on the street." Utah – Students at three junior high schools can now participate in a free afterschool soccer league, which Salt Lake County Youth Services hopes will keep them out of trouble. "By providing an activity they love with positive adult role models, we hope to keep these youth from getting into gangs and help them to concentrate on their school and productive activities," Kelly Riding, manager of the county's afterschool program, told the

Deseret Morning News. Students must maintain good grades to be on the team, and parents are encouraged to participate in Gang 101 presentations by the county Sheriff's Metro Gang Unit to learn communication skills, how to offer homework help to their children, and warning signs of gang involvement.

Virginia – Children at Red Hill Elementary School are learning about the stars from an expert: University of Virginia astronomy professor Kelsey Johnson. Dark Skies, Bright Kids is an afterschool program for third-through fifth-graders at the rural Albemarle county school. The group meets one afternoon a week, followed by observation by telescope in the evening for the students as well as their families. The club kicked off with a "Dinner Under the Stars" potluck, and has also hosted "Astronomy Week" at the school. The program is staffed by volunteer undergraduate and graduate level University of Virginia students.



AFTERSCHOOL ALLIANCE WINS CABLE AWARD

On October 26, the Afterschool Alliance was named the Association of Cable Communicators (ACC) Community Bridges Award recipient. The association created the ACC Community Bridges Award in 2004 to recognize outstanding partners outside of the cable industry.

and expand afterschool programs for children.
Cable has been a key supporter of the
Afterschool Alliance's Public Service
Announcement campaigns by donating time

Association's work to produce two cable specials on afterschool.

Better Outcomes for Middle School Youth

Youth Development Institute recently released findings of an evaluation of its Beacon Out-of-School Time programs Young Adolescent project, which serves middle-school age-youth. The evaluation was conducted to test strategies for the improvement of quality services to middle-school youth in seven New York City Beacons programs and to strengthen attendance, engagement and retention.

It found that "enrollment increased by 18 percent over the previous year in the sites targeted for improvement; attendance increased by 85 percent, with the average total attendance at 236.5 hours across all NYC sites. Continued from page one... the communities that hosted them.

In Birmingham, **Alabama**, sitting atop Red Mountain is the world's largest cast-iron statue – a symbol of Alabama's history at the Vulcan Park and Museum. On October 22, this iconic landmark featured a Light Bulb Art Exhibit that students and other guests toured as part of *Lights On Afterschool*. Guests also learned more about local afterschool programs. Parents and community members, school officials, school board members and superintendents participated.

In Los Angeles, **California**, hundreds of children, parents, business and community leaders came together for a *Lights On Afterschool* rally at City Hall, where the Lindbergh Beacon, a historic relic from the early days of aviation, was lit in honor of the event. The event featured a cooking demonstration by renowned celebrity chef and longtime afterschool supporter Joey Altman. It was organized by Woodcraft Rangers.

The **Maine** Afterschool Network held a statewide *Lights On Afterschool* event in Portland, bringing people together during their lunch hour to watch performances and listen to speakers and distinguished guests. Luminaries included: Maine First Lady Karen Baldacci; Police Chief James Craig; Lauren Sterling of the 21st Century Program; Donna McNeil, Director of the Maine Arts Commission; and Justin Alfond, Co-Chair of the Education and Cultural Affairs Committee. Police Chief Craig called afterschool an "expression of our love for our kids."

In St. Paul, **Minnesota**, Mayor Christopher Coleman said, "We know what works. Let's double our efforts. Let's triple our efforts. Let's make sure all of our children have a safe place to go afterschool." He was speaking at a *Lights On Afterschool* news conference at the State Capitol, where experts discussed the newly released *America After 3PM* state data.

Balloons filled the sky in Ada, **Oklahoma**, for *Lights On Afterschool*,

carrying messages about their program written by students at the Boys & Girls Club of Ada. The *Ada Evening News* reports that one balloon reached northern Illinois, where someone who found it called the program to ask how to send money to sponsor a student.

More than 100 dignitaries and officials hopped aboard two buses in Dallas, Texas, for a special Lights On Afterschool tour. Guests included city, state and federal representatives; a representative from the largest media outlet in the state; program funders; community partners; and representatives of the Juvenile Justice Department. They took concurrent bus tours of north and south Dallas, with each bus touring three sites. The purpose of the bus tour was to highlight high quality afterschool programs – as well as the alternatives in areas where no programs are available to demonstrate the difficult conditions children and youth face without these supports.

Data on Unmet Need for Afterschool

On October 6, the Afterschool Alliance released America After 3PM: A Household Survey on Afterschool in America, the most in-depth study ever to explore how America's children spend their afternoons, at a U.S. Department of Education event featuring Education Secretary Arne Duncan. Sponsored by the JCPenney Afterschool Fund, a charitable organization committed to inspiring children to be smart, strong and socially responsible, it finds that despite an increase in the number of children attending afterschool programs over the last five years, more than a quarter of the nation's schoolchildren are on their own in the afternoons. The parents of 18 million children say they would enroll their kids in afterschool programs, if programs were available. Data from all 50 states were released on October 15.

As in years past, actress Rhea Perlman served as a spokesperson for *Lights On Afterschool*. California Governor Arnold Schwarzenegger is Founding Chair, a position he has held since 2001.
