On Tuesday, afterschool advocates fanned out across Capitol Hill to meet with Members of Congress and congressional staff. In the meetings, advocates discussed the benefits offered by afterschool programs and urged Congress to increase afterschool funding through the 21<sup>st</sup> Century Community Learning Centers initiative and the Child Care Development Block Grant, the chief federal funding streams for afterschool.
