Afterschool Alliance Names Community Educational Services – Chinatown Beacon Center’s Jenny Arcilla-Gonzalez One of 18 ‘Afterschool Ambassadors’ from 15 States

Jenny Arcilla-Gonzalez Will Work in California and Nationally to Expand Afterschool

Washington, DC – The Afterschool Alliance today announced the selection of Jenny Arcilla-Gonzalez, Youth Program Manager of the Afterschool Community Enrichment (ACE) Program, to serve as a 2008-2009 Afterschool Ambassador. She is one of just 18 local leaders from 15 states selected for the honor. Each Ambassador will continue directing or supporting a local afterschool program while also serving a one-year Afterschool Ambassador term organizing public events, communicating with policy makers, and building support for afterschool programs. Arcilla-Gonzalez’ Ambassadorship is supported by Torani – the number one specialty syrup in North America, based in South San Francisco.

“Afterschool programs keep children safe, inspire them to learn, and help working families,” said Afterschool Alliance Executive Director Jodi Grant. “Americans strongly support afterschool programs but there aren’t nearly enough to meet the need, and rising fuel prices and tight budgets at all levels of government are putting financial pressure on the programs we have. In her work as an Afterschool Ambassador, Jenny Arcilla-Gonzalez will bring energy and talent to the task of spreading the word about the need to make afterschool programs available to all families that need them. I look forward to working with her to build support for afterschool among parents, business and community leaders, lawmakers, and the media. We are proud to have Jenny on our team.”

In partnership with the San Francisco Unified School District, the ACE (Afterschool Community Enrichment) Program currently operates at eight elementary schools (Chinese Education Center, Garfield, Gordon J. Lau, Jean Parker, John Yehall Chin, Redding, Sherman and Spring Valley) providing homework assistance, nutrition, recreation and project-based learning opportunities.

Through the ACE Program, 700 students are served on a daily basis during the afterschool hours. ACE provides a safe space to learn and excel academically, encourages real-life application

(testing academic knowledge and applying to real-life situations – to "*learn beyond pen and paper*") and pushes youth participants to become active members and strong leaders within their community.

Each Ambassador will plan a major event for *Lights On Afterschool*, the Afterschool Alliance's October 16 nationwide rally for afterschool. Despite overwhelming public support, and an agreement embodied in the *No Child Left Behind Act* to steadily increase federal funding, federal support for the 21st Century Community Learning Centers initiative – the principal federal funding stream for afterschool programs – has lagged far behind the need. The *No Child Left Behind Act* authorized \$2.5 billion for afterschool this year, but funding is at less than half that level. Congress has not yet completed work on the education budget for Fiscal Year 2009.

This year's *Lights On Afterschool* events will mark the end of a year-long celebration of the 10th anniversary of the 21st Century Community Learning Centers initiative. Last year, a million people rallied at 7,500 *Lights On* events to show their support for afterschool programs.

Afterschool programs offer young people safe, enriching, fun and engaging places to spend their afternoons. Youth in afterschool programs have been shown to perform better in school and have greater expectations for the future, while children who are unsupervised in the afternoons

are at greater risk of becoming involved with crime, substance abuse and teenage pregnancy. A groundbreaking study conducted for the Afterschool Alliance in 2004 (with funding from the J.C. Penney Co., Inc.) concluded that 14.3 million latchkey children have no adult supervision in the afternoons and that the parents of 15.3 million children would send their child to an afterschool program if one were available.

The selection of Arcilla-Gonzalez as an Afterschool Ambassador will help shine a spotlight on San Francisco for this year's *Lights On Afterschool* events in October.
