### **Stamford's Wilson Selected as One of Just 16 Afterschool Ambassadors in Country This Year**

*Tiffany Wilson Will Work in Connecticut and Across Nation to Make Afterschool and Summer Learning Programs Available to More Children and Youth*

Washington, DC – Tiffany Wilson, Senior Manager of Youth & Family Programs at Mill River Park Collaborative, has been selected to serve as a 2023 Afterschool Ambassador, the Afterschool Alliance announced today. She is one of just 16 leaders in the country chosen for the honor this year. Afterschool Ambassadors continue their work with local afterschool programs while serving a one-year Afterschool Ambassador term, organizing events, working with community leaders and policy makers, and in other ways increasing support for the afterschool and summer learning programs families rely on.

"We are absolutely delighted that Tiffany Wilson will serve as a 2023 Afterschool Ambassador," Afterschool Alliance Executive Director Jodi Grant said. "While students and families need afterschool and summer learning programs more than ever, programs are facing significant challenges including staff shortages, funding shortfalls, and finding ways to meet the academic and social needs of students as they recover from the challenges the pandemic created. We need strong, creative champions to spread the word about the essential role afterschool programs play in keeping kids safe, inspiring them to learn, and giving parents peace of mind that their children are safe and supervised after the school day ends. Wilson is poised to be just the kind of powerful advocate we need."

"I am looking forward to joining the Afterschool Alliance in growing support for afterschool and summer learning programs this year," said Wilson. "I've seen up close the incredible ways these programs support youth and their families, and the critical resources and services they provide. That's even more important now, as we recover from the isolation and hardship the pandemic caused. It is imperative that we continue working toward bridging the gaps that exist in our communities by providing quality and equitable programs for all. I'm so proud to be part of the afterschool movement and to have a chance to serve as an Afterschool Ambassador for Connecticut this year."

Mill River Park Collaborative's programming and amenities have been a staple in the Stamford community for the past decade. Located in downtown Stamford, Mill River Park is home to the Brownstein|Selkowitz Carousel Pavilion, the Whittingham Discovery Center, and the Cohen Ice Skating Center. The Collaborative's youth camps serve over 200 kids annually, including both vacation and summer camp programs. These camps focus on STEM (science, technology, engineering and math), social and emotional learning (SEL), ice skating, cooking, arts and crafts, sports, and more. Devoted to

the community it serves, Mill River Park Collaborative takes pride in ensuring its programming is both accessible and relevant to Stamford residents and beyond.

Each Ambassador will organize a major event for *Lights On Afterschool*, the Afterschool Alliance's annual rally for afterschool. Most of the thousands of local *Lights On Afterschool* events will be on or around Thursday, October 26, 2023.

Some 24.7 million U.S. children not in an afterschool program would be enrolled, if a program were available to them, according to [a survey of nearly 1,500 parents](#) commissioned by the Afterschool Alliance and conducted by Edge Research in May and June of 2022. That is the highest number ever recorded. Unmet demand for afterschool programs is significantly higher among Latino and Black children (at 60% and 54% respectively) than among children overall (49%). Cost is the top barrier to enroll, cited by 57% of parents as a reason for not enrolling their child. Ninety percent of parents rate the quality of the program their child attends as excellent (51%) or very good (39%).

A large and powerful body of evidence demonstrates improvements in grades, school attendance, behavior and more among children who participate in afterschool programs. Researchers have also found that students in afterschool programs are more engaged in school and excited about learning and develop critical work and life skills such as problem solving, teamwork, and communications.
